- Townsend moved; Horn seconded to send out 57 landscape maintenance letters. Motion passed unanimously.

#### **NEW BUSINESS**

Personnel – Executive session reviewed contracts and performance of Adele Cooke & Teresa Baron. Horn moved; Townsend seconded to give Secretary/Bookkeeper a 3% cost of living increase to base salary beginning in December 2019 and a \$500 bonus for work on audit. Timesheet to be kept to review hours spent on positions. Motion passed unanimously.

Horn moved; Townsend seconded to give Manager a 3% cost of living increase on her salary when adjusted for the 5% increase to her base salary beginning December 2019 and a 5% base salary increase in December 2020. In addition a \$5,000 bonus will be paid for savings on road project. Motion passed unanimously.
